I agree that I will release "I cycle Holland" from any and all responsibility or liability for injuries or damages to the user of the equipment listed on this check-list or to any other person. I agree not to make a claim against or sue this bicycle shop for injuries or damages relating to bicycling or the use of this equipment.
